- 2. Bidding will be conducted through National Competitive Bidding Procedure
- 3. In order to eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements.
  - The bidder shall have ICTAD Registration Grade EM 4 or above under category of Mechanical Ventilation and Air Conditioning (MVAC)
  - The bidder shall be a reputed local company having experience in planning, engineering, supplying, installing, testing, commissioning and maintenance of similar type of air conditioning system at least for last five (05) years.
  - The manufacturer of the water cooled package air conditioning equipment shall have at least ten (10) years experience in the design and manufacture of similar type Air conditioning equipments.
  - The make of water cooled package type AC system offered shall have satisfactory service record in Sri Lanka at least for last five (05) years.
- 4. Qualification requirement to qualify for contract award include:
  - Average annual value of similar type Air conditioning work performed in last five years shall be at least **Rs.18 Million**
  - The minimum amount of Liquid Assets or credit facilities required is **Rs. 2.4 Million**.
- 5. Interested bidders may obtain information pertaining to same from Director Finance & Administration, IBSL and inspect the bidding documents free of charge at IBSL from 09.00 hrs. to 15.00 hrs. during Monday to Friday from 26/09/2016 until 30/09/2016.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written request to Director Finance & Administration, IBSL from 26/09/2016 to 04/10/2016 from 09.00 hrs. to 15.00 hrs. upon payment of a non refundable fee of Rs. 2,000.00. The method of payment shall be cash.

- 8. All bids shall be accompanied by a Bid Security of **Rs.45,000.00** from any of the authorized party prescribed in the National Procurement Agency (NPA) Guidelines which shall be valid for a period of **119 days** from the date closing of bids.
